



TRAGEDY FOR A CNOC FAMILY

AS THE NATION MOURNED THE FATALITIES OF LEBANON'S PEACE KEEPING FORCE, CAPTAIN L. J. PINGEL, COMNAVOCEANCOM FORWARDED SPECIAL CONDOLENCES TO CWO (AEROGRAPHER) PAUL "PABLO" AND MARIA LYON WHOSE OLDEST SON, 21 YEAR OLD LANCE CORPORAL PAUL DEAN LYON, JR., USMC WAS AMONG THE 23 OCTOBER BEIRUT CASUALTIES. PAUL JR WAS BORN IN ROTA SPAIN OCTOBER 20, 1962 AND HE JOINED THE MARINE CORPS UPON GRADUATING MILTON HIGH SCHOOL, MILTON, FLORIDA IN 1981. CWO LYON WAS ASSIGNED AS OFFICER-IN-CHARGE OF NAVOCEANCOMDET WHITING FIELD UNTIL HIS TRANSFER TO NAVOCEANCOMCEN ROTA IN LATE SEPTEMBER.

FUNERAL SERVICES WERE HELD 7 NOVEMBER AT ST. ROSA OF LIMA CATHOLIC CHURCH WITH BURIAL AT SERENITY GARDENS WITH FULL MILITARY HONORS. THE MAYOR OF MILTON PROCLAIMED A DAY OF MOURNING.

PAUL JR WAS A MEMBER OF THE ST. ROSA OF LIMA CATHOLIC CHURCH OF MILTON. HE WAS AN ACTIVE LEADER IN THE YOUTH GROUP AND THE CHURCH'S BUILDING PROJECT. AFTER JOINING THE MARINES, PAUL CONTINUED SUPPORTING THE CHURCH AND ITS PROJECTS. IN HONOR OF HIS LOYALTY AND DEDICATION TO HIS COUNTRY AND TO HIS CHURCH, THE BUILDING PROJECT HAS BEEN REDEDICATED IN HIS HONOR. PERSONAL DONATIONS MAY BE FORWARDED IN THE NAME OF: LCPL PAUL DEAN LYON, JR. ST. ROSA OF LIMA BUILDING FUND 515 PARK AVENUE SW MILTON, FLORIDA 32570

SURVIVORS INCLUDE HIS PARENTS, PAUL AND MARIA; THREE SISTERS, JUNE, VALERIE AND ELIZABETH; TWO BROTHERS, EARL AND FRANCISCO. PAUL WAS ALSO THE NEPHEW OF AGCS WAYLAND DEAN SLACK AND AGC LEO GRENIER, USN (RET).

NAVY MEMORIAL FOUNDATION

The Navy Memorial Foundation received final approval in early November, 1983, to build a ten million dollar memorial to NAVY men and women in Washington, D.C.

The National Capital Planning Commission approved design concepts for the privately financed structure which will be located on Pennsylvania Avenue between the U.S. Capitol and the White House, directly across from the National Archives.

Key elements of the project:

- An amphitheater with a multipurpose modern concert stage to be used by the Navy Band, other military musical organizations and performing arts groups.

An inscribed grid of the Western Hemisphere engraved into the entire deck of the amphitheater.
A life-size statue of "The Lone Sailor," placed at the north polar coordinate of the Western Hemisphere grid.

- A series of bronze reliefs positioned around the amphitheater depicting historic naval events.

- Two fountains with sculptures of naval men in peril on the sea.

- A special area to conduct official Navy ceremonies.

Construction of the memorial is expected to take about three years. All contributions are tax deductible. For more information write c/o P.O. Box 332, McLean, VA 22101.

A NEW FEDERAL HOLIDAY

After much debate, the United States Senate voted Martin Luther King's birthday (January 15th) as the tenth legal federal holiday in these United States of America. The House-sponsored 'resolution was passed by a 78 to 22 vote on October 19, 1983. The new holiday is to be observed beginning January 15, 1986.

THIS IS TRIDENT

When compared to the ballistic missile submarines that have been operational in recent years, TRIDENT's specifications are awesome. With a length of 560 feet and a submerged displacement in excess of 18,000 tons, the GEORGE WASHINGTON class is, by contrast, seemingly only a scale model at 380 feet and 5,900 tons.

While exact figures are classified, the TRIDENT is reported to be capable of submerged speeds in excess of 30 knots at depths greater than 400 feet. The fissionable material that fuels the 90,000 horsepower reactors will last ten years, sufficient to travel more than 400,000 miles nonstop. The only limitations on length of cruises are crew endurance and supplies (read: chow).

Each of these undersea behemoths is manned by 154 officers and crewmen. Two alternating crews, the Blue and the Gold, are assigned to each TRIDENT, as with other ballistic missile submarines. Typically, a patrol lasts 70 days, spent entirely under submerged conditions.

HISTORIAN'S NOTE

U.S.S. BARRY (DD-933)

You may visit and tour ex-destroyer USS BARRY at Washington Navy Yard commencing in February, 1984. She was brought to Pier Twp at WNY mid-November 1983. It took the NAVY nine years to plan and select a ship for permanent display in the nation's capital.

BARRY was commissioned in 1956 and decommissioned in 1982. She was prepared for display purposes by Ships Intermediate Maintenance Activity, Philadelphia, and by Maryland Ship-building Company, Baltimore. Cost of these modifications: \$475,000 (approx).

She was named for American Revolutionary War naval hero Commodore John Barry. This FORREST SHERMAN-class ship will be opened to the public for tours of main deck and bridge area only. Voluntary contributions may prove to be sufficient to later permit tours of below deck spaces.



WOMAN AG PIONEER

IN JANUARY, 1983, ONE OF THE FIRST WOMEN IN THE AEPOGRAPHER'S MATE COMMUNITY DIED. HAZEL ERNESTINE JEFFREY, 70, LCDR, USNR (RET) DIED JANUARY 5 IN RENTON, WA. A NATIVE OF WASHINGTON STATE, SHE ATTENDED WESTERN WASHINGTON COLLEGE OF EDUCATION IN BELLINGHAM, RECEIVING HER TEACHING CERTIFICATE IN 1936. SHE TAUGHT ET.E E TRY SCHOOL IN LOWELL, WA FROM 1936 TO 1941 WHEN SHE ATTENDED UNIVERSITY OF WASHINGTON. SHE GRADUATED IN 1942 WITH A BA IN SOCIAL SCIENCE. IN NOVEMBER 1942 SHE ENLISTED IN THE USNR AND GRADUATED FROM BOOT CAMP AT CEDAR FALLS, IOWA, IN JANUARY 1942. IN FEBRUARY 1943 SHE ATTENDED AEROGRAPHER'S MATE SCHOOL TN LAKEHUR.ST, N.J. AFTER GRADUATION SHE WAS RETAINED ONBOARD AS AN INSTRUCTOR AND ADVANCED TO AEROGRAPHER'S MATE THIRD CLASS. SHE TAUGHT IN THE OLD NE MAN SCHOOL IN LAKEWOOD, N.J. IN DECEMBER 1943 AND JANUARY 1944 SHE ATTENDED OFFICER CANDIDATE SCHOOL IN NORTHAMPTON, MASS., AND WAS APPOINTED ENSIGN, USNR. FROM FEBRUARY 1944 TO FEBRUARY 1945 SHE WAS THE ASSISTANT ENLISTED EDUCATION OFFICER AT NAAS CABANNIS FIELD, CORPUS CHRISTI, TX. INCLUDED IN HER DUTIES WAS TEACHING BLACK SAILORS TO READ AND WRITE. IN MARCH 1945 SHE REPORTED ABOARD NAS KAHUIJJI, MAUI, HAWAII. SHE WAS EDUCATION OFFICER AND ASSISTANT SHIPS SERVICES OFFICER. AS THE AIR STATION BEGAN CLOSING DOWN AFTER VJ DAY. SHE ALSO BECAME THE ASSISTANT COMMISSARY OFFICER. IN MARCH 1946 SHE WAS RELEASED FROM ACTIVE DUTY IN SAN FRANCISCO. IN 1946 AND 1947 SHE DID GRADUATE WORK IN RUSSIAN LANGUAGE AT THE UNIVERSITY OF WASHINGTON. AFTER WORKING FORA YEAR AND A HALF AS A COST ACCOUNTANT IN SAN FRANCISCO SHE RETURNED TO WASHINGTON IN 1949 AND WORKED AT A PRINTING AND PUBLISHING FIRM IN SEATTLE FOR TWENTY SIX YEARS, IN 1951 SHE JOINED THE US NAVY RESERVE WEEKEND WARRIORS AT NAS SEATTLE. SHE SERVED IN MANY CAPACITIES

IN SEVERAL UNITS INCLUDING HELICOPTER UTILITY SQUADRON (HU 891). SHE SPENT MANY YEARS IN TRANSPORT SOUADRON (VR 891) AND WENT ON CRUISES TO NORTH AFRICA, EUROPE, AND HAWAII. IN 1972 SHE RETIRED FROM THE NAVY RESERVE A LIEUTENANT C 4ANDER. IN 1976 SHE RETIRED TO CAMINO ISLAND, WA.

CONSTITUTION AND BYLAWS

=<u>PREAMBLE</u>=

The Naval Weather Service Association was formed by and for persons associated at any time with the Naval Weather Service, its predecessor or its successor organizations.

We associate ourselves together for the following purposes:

- To uphold the Constitution of the United States of America.

- To support a strong military defense posture of the United States of America.

- To preserve the memories and incidents that were a part of our personal lives and professional associations.
- To promote the fraternalism and camaraderie within the Naval Weather Service Assoc.

This organization was established as a non-political organization and will remain so throughout its existence.

= <u>B Y L A W S=</u>

ARTICLE I – NAME

Section 1. Name

The name of the organization is the Naval Weather Service Association (hereinafter referred to as NWSA).

ARTICLE II – POWERS AND CONSTRAINTS

<u>Section 1. Powers</u> The powers of NWSA reside in its members. These powers are exercised on behalf of the membership by an Executive Board.

<u>Section 2. Constraints.</u> The NWSA is nonprofit, nonsectarian and nonpartisan. It cannot endorse or disparage a commercial enterprise, a political platform, or a candidate for public office. No part of any funds collected or received from any source shall inure to the benefit of any member or individual, and no officer of the NWSA shall receive compensation for services as an officer.

ARTICLE III - MEMBERSHIP

<u>Section 1. Eligibility.</u> Any person, military or civilian, who has served honorably or been closely associated with any unit of Naval Weather Service, its branches or detachments, ashore or afloat, is eligible for membership. The spouse of a deceased member shall be eligible for continued member-ship in the NWSA.

<u>Section 2.</u> Application. Application for member-ship shall be made in writing, accompanied by Annual Dues and Registration Fee currently in effect (the latter for non-active-duty persons only), to the NWSA Secretary-Treasurer.

<u>Section 3. Reinstatement.</u> Membership may be rein-stated by payment of the Annual Dues at any time, except that after a lapse of one year or longer the Registration Fee will be required.

<u>Section 4. Standing.</u> A member shall be considered in good standing with entitlement to all NWSA benefits, including voting, if dues are paid for the current fiscal year beginning July 1 and ending June 30.

ARTICLE IV – DUES

<u>Section 1.</u> Annual dues will be as set by the Executive Board and approved by the majoririty of members present at the Annual Meeting. Dues are payable July 1 for the ensuing fiscal year and become delinquent after October 1.

<u>Section 2</u>. Life_membership shall be available for the lump-sum amount of twenty-five (25) times the current annual dues.

<u>Section 3. Registration Fee.</u> There will be a Registration Fee for non-active duty new members in addition to Annual Dues. It shall be a one-time fee, not to be repeated if dues are kept current, and

payable on application for membership. The amount of the Registration Fee shall be set by the Executive Board.

ARTICLE V - OFFICERS

<u>Section 1.</u> Elected officers shall be the President, First Vice-President, Second Vice-President, and Secretary-Treasurer.

Section 2. Terms Of Office. The officers of NWSA shall serve for a term of one year.

<u>Section 3.</u> Officers-Elect. When elected, officers shall be designated "Officers-Elect" for an interim period of one year before assuming responsibilities of office.

<u>Section 4.</u> Appointive officers. The Editor of the NWSA newsletter, Sergeant-at-arms, Historian, Chaplain and Parliamentarian shall be appointed annually by the newly-elected President, and shall serve for the duration of his term unless they decease or resign.

<u>Section 5.</u> Replacement and Succession. In the event of a vacancy through resignation or other reason among the elected officers, normal ascension will apply. The Officers-Elect will not assume a vacated office.

ARTICLE VI - EXECUTIVE BOARD

<u>Section 1. Composition.</u> The Executive Board shall consist of the officers of the NWSA as set forth in Article V, the Past Presidents, Historian, Chairman of the Reunion Committee, and the President of each NWSA Regional Chapter as defined in Article XIV

<u>Section 2. Quorum.</u> Five members of the Executive Board including at least one elected officer, present in person, shall constitute a quorum.

ARTICLE VII - ELECTIONS

<u>Section 1.</u> Election of officers will be conducted at the Annual Meeting. Officers elected will pre-pare to take office immediately following the elections held at the Annual Meeting one year in future, a unique but necessary arrangement generated by the association's goal for rotating Annual Meetings geographically.

ARTICLE VIII - DUTIES OF OFFICERS

<u>Section 1. President.</u> The President shall preside at all meetings of the Executive Board and the NWSA; shall appoint the Chairman of each committee and directly or indirectly supervise their work; shall act as Executive Officer of NWSA and in general perform the duties usually associated with the office of President.

Section 1. First Vice-President.

The First Vice-President shall succeed to the presidency in case of a vacancy in that office and shall perform the duties of the President in his absence or disability; and shall undertake such other responsibilities as the President may assign.

Section 3. Second Vice-President.

The Second Vice-President shall succeed to the First Vice-Presidency in case of a vacancy in that office and shall perform the duties of the First Vice-President in case of absence or disability; and shall undertake such other responsibilities as the President may assign.

Section 4. Secretary-Treasurer.

The Secretary-Treasurer shall handle the correspondence of the NWSA and maintain a record of the proceedings of all meetings of the membership and Executive Board; shall be custodian of all records of the NWSA; shall receive all revenues of NWSA and disburse all such funds; shall present an annual report to the membership at the Annual Meeting, listing all receipts and disbursements by budget categories; and shall publish annually the BELLINGER LIST by November 1st, and the Re-port of Annual Meeting (Reunion/Convention) within six weeks of same.

Section 5. Editor, "THE AEROGRAPH"

The Editor of THE AEROGRAPH shall publish the quarterly newsletter and make distribution to NWSA members in good standing, using current membership information obtained through close cooperation with the Secretary-Treasurer. Prior to each Annual Meeting, a broader distribution to include nonmembers in appropriate geographical areas may be made to encourage their participation in the Reunion/Convention.

<u>Section 6.</u> Parliamentarian. The Parliamentarian shall be versed in the Bylaws of NWSA and the <u>Robert's Rules of Order</u>, and shall ensure that all meetings of the NWSA are conducted accordingly.

<u>Section 7.</u> <u>Historian.</u> The Historian shall acquire appropriate records of persons and incidents considered to be part of NWSA, in order to preserve the past of Naval Aerology and the Naval Weather Service and persons associated therewith; and shall perform such other duties as may properly pertain to the office or be determined by the President or the Executive Board.

Section 8. Sergeant-At-Arms.

The Sergeant-at-Arms shall preserve order at all meetings of NWSA; shall welcome all visitors; shall see that the colors are posted at all meetings of NWSA; conduct all honored guests until seated and recognized; and shall perform such other duties as may be assigned by the President.

<u>Section 9.</u> Chaplain. The Chaplain, as the spiritual leader of NWSA, shall give the Invocation and the Benediction at all formal NWSA meetings and at such other meetings when/as called upon; and shall be responsible for re-porting on those members who have deceased or who are ill.

ARTICLE IX - STANDING COMMITTEES

Section 1. The standing committees of the NWSA shall be: Reunion, Museum and Audit.

Section 2. Special committees (ad hoc) may be appointed by the President as need arises.

Section 3. Terms of all committee members shall expire at the Annual Meeting.

Section 4. Duties of Standing Committees.

a. <u>Reunion Committee.</u> The appointed chairman shall select committee members. The committee shall plan in sufficient time for the entire reunion/convention program, including agenda, lodgings, meals, special activities, etc. The committee shall publish announcements indicating schedule of events, allowing sufficient time for such information to reach the membership and others who are considered interested. A <u>Reunion Turnover Book</u> shall be maintained by the committee and shall be passed on to the succeeding chairman. Under no circumstances shall the committee obligate the NWSA for finances unless specifically approved by the Executive Board. Reunion costs must be borne by the attendees.

b. <u>Museum Committee.</u> The President shall appoint a Museum Committee of three members and shall designate one of them Chairman. The committee shall provide a point of contact for essential coordination by the Director, Naval Aviation Museum, Pensacola, also coordinating programs and actions with the NWSA Historian. The committee shall submit an annual status report to the President, including recommendations on the NWSA museum program.

c. <u>Audit Committee.</u> The President shall appoint an Audit Committee of three (3) members and shall designate one of them Chairman. The committee shall examine, adjust, and certify the correctness of the

fiscal records of NWSA; shall audit the financial records at the end of each fiscal year; and shall submit a report in writing to President.

ARTICLE X - MEETINGS

<u>Section 1.</u> <u>Executive Board.</u> There shall be a minimum of two (2) meetings of the Executive Board per year. All Board members shall be notified of the date, place, and time of each meeting.

<u>Section 2.</u> Annual Meeting. A general membership meeting (reunion/convention) shall be held each year during the summer months. Insofar as possible, the Annual Meeting will be held alternately in the eastern, central, and western geographical regions of the United States. Election of officers will be conducted as part of each Annual Meeting.

<u>Section 3.</u> Local Coordination. An objective of the Annual Meeting is coordination of planning and events with any nearby elements of the Naval Oceanography Command or other successor to the Naval Weather Service, to the end that mutual benefits may accrue.

Section 4. Order of Business. The following shall be the Order of Business for NWSA meetings:

- 1. Reading of Minutes of previous meeting
- 2. Reports of officers
- 3. Reports of committees
- 4. Election of officers
- 5. Unfinished business
- 6. New business
- 7. Adjournment

ARTICLE XI - PARLIAMENTARY AUTHORITY

<u>Section 1. Robert's Rules of Order</u> shall govern the conduct of business in all cases in which they are applicable and not in conflict with these Bylaws.

ARTICLE XII - DISSOLUTION

<u>Section 1.</u> In the event of dissolution of the NWSA, or in the event it shall cease to exist for its objectives as stated in the Preamble, all assets shall be consigned to the Navy Relief Society. Under no circumstances shall any asset of the NWSA during the existence and/or dissolution thereof go and be distributed to any officer or member.

ARTICLE XIII - EFFECTIVE DATE & AMENDMENTS

<u>Section 1.</u> This Constitution and Bylaws shall become effective when adopted by a two-thirds (2/3) vote of NWSA members.

<u>Section 2.</u> This Constitution and Bylaws may be amended by having the proposed amendment submitted to the Secretary-Treasurer for reading at the Annual Meeting, after which adoption shall require a two-thirds (2/3) vote of the members assembled at the next Annual Meeting. The Secretary-Treasurer shall distribute to the membership any such proposed amendment at least thirty (30) days prior to the Annual Meeting it will be voted upon.

ARTICLE XIV - REGIONAL CHAPTERS

<u>Section 1.</u> The President may recognize Regional Chapters (NWSA) such as Southern California, Jacksonville, Rhode Island, etc.

<u>Section 2.</u> Regional Chapters (NWSA) shall be comprised of ten (10) or more members of the NWSA, with purpose and goals consistent with those of NWSA. To be a voting Chapter member, NWSA member-

ship is required. A Regional Chapter shall meet, operate, and function independently under locally elected officers, and shall meet a minimum of twice each year. The Regional Chapter President shall serve on the NWSA Executive Board.

Section 3. The NWSA Constitution and Bylaws shall be adhered to by each and every Regional Chapter.

These are the current Bylaws approved and adopted by the membership on 28 June, 1979, including Amendments approved through Annual Meeting held on 25 June, 1983 in San Jose.
